TERMS & CONDITIONS*

Generic

- 1 Each player must affiliate himself/herself with SPORTIME (the "Club") as a Member or as an Associate (where applicable) by completing and signing the appropriate documents and, if the player affiliates himself/herself as a Member, by paying the dues designated for the type of membership chosen by the player.
- 2 Seasonal play begins and ends as per the information on the Rate/Schedule Card for the seasonal year.
- 3 **THIS CONTRACT MUST BE ACCOMPANIED BY A DEPOSIT AS DESIGNATED ON THE RATE/SCHEDULE CARD. THE DEPOSIT IS NOT REFUNDABLE. THE BALANCE OF ALL FEES AND TAXES IS TO BE PAID IN FULL BY OCTOBER 24. IF PAYMENTS ARE NOT MADE AS REQUIRED ABOVE, THE CLUB RESERVES THE RIGHT TO CANCEL THIS CONTRACT AND TO RETAIN ALL MONIES. THE CLUB RESERVES THE RIGHT TO CHARGE A LATE FEE ON ALL PAST DUE BALANCES. By signing this Contract, the Captain agrees that he/she is responsible for the full cost of the reserved seasonal court. Cancellation of a reserved seasonal court by the group, or the departure of one or more seasonal players from a seasonal group, prior to or during the season, shall not alleviate the Captain of his/her responsibility under this paragraph.**
- 4 When the Club is responsible for lost playing time by reason of emergency or unexpected conditions, make up time will be scheduled with the Captain based on court availability. Seasonal time, unused by the playing group because of personal reasons, cannot be made up. If the playing group cannot use seasonal time because players choose to observe a religious holiday which is not included in the "out dates", make up time will be guaranteed and will be scheduled with the Captain based on court availability. All makeup time must be used by August 31.
- 5 The use of courts beyond the assigned time will be subject to charge.
- 6 The Captain and all players, by signing this Contract, hereby agree to abide by all rules and regulations of the Club which now exist or which may be hereafter adopted or amended by the Club, including, but not limited to, the Seasonal Court Handbook. **The Captain and each player agrees that he/she, as a condition of this Contract and as a condition of having received a preferred Member rate, if applicable, must maintain his/her membership in good standing for the duration of the seasonal contract.**
- 7 The Club reserves the right to terminate this Contract at any time for unsportsmanlike conduct on the part of any player or players, or for any other reason deemed to be good and sufficient by the Club's management, in which event, the unexpired portion of the court rental payment shall be returned to the Captain and neither the Club nor the Captain shall be under any further liability on account of this Contract. No refunds shall be given except as provided in this paragraph.
- 8 By signing this Contract, the Captain and all players acknowledge and agree that there are certain inherent dangers in playing tennis and that the Club shall not be liable for any personal injuries, property damage, or other loss sustained by the undersigned in, on or about the premises of the Club, or arising out of the use or intended use of any facilities, equipment or other property of the Club, whether or not said personal injuries, property damage, or other loss sustained by the undersigned is the result of the negligence of the owners, agents or employees of the Club or the negligence of any other persons present on the premises of the Club. These conditions apply individually and/or jointly with other players, player's children or guests of players.
- 9 All court assignments are at the management's discretion.
- 10 If a seasonal court group has both Member and Non-Member participants (where applicable), the Captain will be charged at the discounted Member rate for each Member participant's share of the court and at the Non-Member rate for each Non-Member participant's share of the court.
- 11 The Captain and all players understand and agree that SPORTIME retains the rights to any photographs or video taken at the facility to be used for marketing, publicity or advertising purposes.
