Patron accepts full responsibility for the use by participants of any and all apparatus, appliances, facility privileges, or services whatsoever, owned and operated by SPORTIME, at their own risk. Patron shall hold SPORTIME, its shareholders, directors, officers, employees, representatives, and agents harmless from any and all loss, claim injury, damage, or liability sustained or incurred by participants resulting therefrom. SPORTIME reserves the right to make additional charges (which will be deducted from the security deposit) including overtime for staff, for affairs running beyond the agreed upon time.
