I understand that SPORTIME *(the "Club") is responsible for supplying the tennis courts, sports instructors, sports equipment, and a party room. By signing below I agree that I am the parent or legal guardian of the above student and that we will abide by all rules and regulations which now exist or which may be hereafter adopted or amended by the management of the Club. I further acknowledge and agree that there are certain inherent dangers in playing tennis and that the Club shall not be liable for any personal injuries, property damage, or other loss sustained by me or my children in, on or about the premises of the Club, or arising out of the use or intended use of any facilities, equipment or other property of the Club, whether or not said personal injuries, property damage, or other loss sustained by the undersigned is the result of the negligence of the owners, agents or employees of the Club or the negligence of any other persons present on the premises of the Club. These conditions apply individually and/or jointly with other players, players' children or guests of players. If I enroll my child(ren) in Club programs and am asked to furnish the Club with appropriate medical exams and records of immunization I agree to furnish such exams and records. In addition, in case of accident or injury to my child and if an emergency contact person cannot be reached, I grant the Club permission to obtain medical attention for my child if necessary, for which I will be financially responsible. The Club reserves the right to cancel this contract at any time, at its sole discretion, and management's sole liability shall be to refund any amounts previously paid on a pro-rata basis.
